The fitout of the facility was completed in September 2019 and secured an 'AA' rating from the British Retail Consortium ("BRC"), a requirement of major retailers in January 2020. Facility Overview	Location Airlinks Industrial Estate is a well-established multi-let industrial estate located close to the M4 (Junction 3) and A312 providing excellent access to Heathrow Airport, central London, and the national motorway network. Comprising 481,000 sq. ft of warehouse space across 47 units the estate benefits from 24/7 access, 24-hour on-site security, CCTV, and on-site catering facilities. Facility The property comprises a standalone industrial / warehouse unit situated at the entrance to the estate with self-contained yard and car parking for 31 vehicles. The premises comprise a total GIA of 18,564sq. ft over two floors plus an additional mezzanine area comprising 1,767 sq. ft. The fitout of the facility was completed during 2019 comprising top quality fixtures, fittings, machinery, and equipment and is powered by a state-of-the-art Certus steam generator. The facility subsequently opened in late 2019 and currently has capacity to produce 16,000 meals per day based on a five-day shift pattern.
